

BCBA SMALL BUSINESS SERIES PRESENTED BY OSCAR HEALTH SWEEPSTAKES

OFFICIAL SWEEPSTAKES RULES

1. Sweepstakes Description: The following terms and conditions (the “Official Sweepstakes Rules”) shall apply to the *BCBA Small Business Series Presented by Oscar Health Sweepstakes* (the “Sweepstakes”). An individual resident in the State of New York who, during the Sweepstakes Period (as defined below), completes and submits that certain Sweepstakes entry form available via www.barclayscenter.com (each such entry, an “Entry”), will be entered into a pool of Entrants (as defined below) and provided with an opportunity to win (a) access to and use of the Barclays Center “pop-up” retail space adjacent to Barclays Center on Flatbush Avenue in Brooklyn, New York for an amount of time determined by Brooklyn Events Center, LLC (“BEC”) in its sole discretion to showcase its products/services and (b) certain branding in Barclays Center (all specifications and details related to the foregoing prize shall be determined by BEC in its sole discretion) (the “Prize”).

ARV of the Prize: up to \$15,000

2. Sweepstakes Period: The Sweepstakes begins at 12:00 AM on October 17, 2018 and ends at 11:59 PM on April 11, 2019 (the “Sweepstakes Period”). Any entries received after the Sweepstakes Period shall be null and void, and ineligible for the Sweepstakes. BEC is not responsible for late, incomplete, or misdirected entries, nor is it obligated to publicly announce the Sweepstakes results.

3. To Enter: NO PURCHASE NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. A PURCHASE WILL NOT INCREASE OR IMPACT YOUR CHANCES OF WINNING. In order to be entered into the Sweepstakes, an eligible entrant (“Entrant”) must, during the Sweepstakes Period, complete and submit that certain Sweepstakes entry form available via www.barclayscenter.com.

All Sweepstakes entries, including, without limitation, all Entries, become the exclusive property of BEC. By entering the Sweepstakes, Entrant acknowledges and agrees that Entrant irrevocably transfers and assigns to BEC all right, title and interest, throughout the world, in and to Entrant’s Entry and BEC shall have exclusive, unlimited ownership rights to all Entries created and submitted to BEC in connection with the Sweepstakes, whether as individual items or as combinations of components. Entrant hereby agrees to give BEC all reasonable assistance and to execute all documents necessary to assist and/or enable BEC to perfect, preserve, register and record its rights in and to Entrant’s Entry.

By entering the Sweepstakes, as described above, Entrant consents (a) to being contacted by BEC and its affiliates and designees; and (b) to be bound by, and comply with, all of the terms and conditions set forth in these Official Sweepstakes Rules.

Limit: One (1) entry per person during the Sweepstakes Period.

4. Eligibility: VOID WHERE PROHIBITED. Entrants must be at least 18 years of age at the time of entry and reside in the State of New York. Sweepstakes is void where prohibited or restricted by law. Employees, officers and directors (and their parents, siblings, spouses and children) of (a) BEC; (b) its advertising and promotional agencies; and (c) their respective parents, subsidiaries or affiliates, are not eligible to participate in the Sweepstakes.

5. Selection of the Winners and Notification: Subject to the terms and conditions set forth herein, there will be one (1) Prize winner (a “Winner”) selected from among all qualifying Entrants on or about each of

November 15, 2018, February 14, 2019, and April 12, 2019. Each Winner will be chosen randomly from among all Entrants' Entries.

Each Winner will be notified via phone call or e-mail within three (3) days of their selection as a Winner. If a Winner either: (a) is unreachable; (b) does not make direct contact with BEC by the time specified in the notification message; (c) fails to accept the Prize; or (d) fails to sign BEC's standard Release, BEC reserves the right, in its sole and absolute discretion, to disqualify such Winner and, to select a replacement Winner from the remaining qualifying Entrants. BEC shall not be responsible for failed attempts to notify the Winners and no responsibility is assumed by BEC for any correspondence returned as undeliverable or any other problems associated with attempt(s) to notify such Winner. Odds of winning depend upon the number of eligible entries received.

6. Winner Verification: Upon the request of BEC, each Winner must sign and return the following documents: (a) an affidavit of eligibility; (b) a liability/publicity release in form and substance satisfactory to BEC; and (c) any other releases and waivers requested by BEC, releasing BEC from any and all liability, loss, claims, demands and causes of action for or related to personal injury, damage, theft, loss, or any other harm suffered in connection with the Sweepstakes or Prize. If any of the foregoing documents are not completed, signed, and returned prior to the time specified in the notification message, or if a Winner is deemed by BEC to be ineligible or not to have complied with these Official Sweepstakes Rules, then such Winner will be disqualified and an alternate Winner will be selected from the remaining eligible entries, time permitting.

7. Prize Conditions, Terms and Restrictions: Only the Prizes described in these Official Sweepstakes Rules shall be awarded and no substitutions, cash equivalents and/or redemptions shall be made, except that, in the event of Prize unavailability, BEC reserves the right to substitute the Prize with another prize of equal or greater value, in BEC's sole discretion. The Prizes cannot be transferred, assigned, or redeemed for cash. Unless otherwise set forth herein, each Winner shall be solely responsible for any and all costs not specifically described as part of the Prize, including any and all of his/her travel expenses and accommodations. All travel arrangements shall be made by the Winners.

Except where prohibited by law, Prize acceptance constitutes a release granting BEC and its designees the right to use each Winner's names, likenesses, statements (if true), biographical information, voices, and cities and states of residence for advertising, marketing and publicity purposes on a worldwide basis (without review by such Winner) and in all forms of media, without compensation, remuneration, or other authorization. BEC expressly disclaims any responsibility or liability in connection with injury or loss to any person or property relating to redemption of the Prize. BEC makes no representations or warranties in connection with the Prize. Restrictions, conditions and limitations apply.

8. Posting Terms and License to Use Entrant Personal Information: In order to promote, market and publicize the Sweepstakes, BEC and its respective affiliates may require a license to use any and all information, materials and content submitted in the Sweepstakes including, but not limited to, each Entrant's name (and likeness), biographical information, and any other personal information submitted. Accordingly, by submitting an entry, each Entrant expressly grants to BEC a worldwide, perpetual, irrevocable, royalty-free, non-exclusive, sub-licensable and transferable right and license to use, however BEC may deem fit in its sole and absolute discretion, whether in connection with the Sweepstakes or otherwise, all content submitted in connection with an entry.

9. Sweepstakes Conditions: The Sweepstakes is governed by and subject to all applicable federal, state, and local laws. By participating, Entrants waive any right to claim ambiguity in the Sweepstakes or in these Official Sweepstakes Rules. Any violation of these Official Sweepstakes Rules may result in disqualification and any violation of these Official Sweepstakes Rules by a Winner will result in such

Winner's disqualification as a Winner and all privileges as a Winner shall be immediately terminated. ENTRANTS RELEASE, DISCHARGE, AND AGREE TO INDEMNIFY AND HOLD HARMLESS BROOKLYN EVENTS CENTER, LLC, AEG MANAGEMENT BROOKLYN, LLC, BARCLAYS BANK, AND EACH OF THEIR RESPECTIVE DIRECTORS, OFFICERS, EMPLOYEES, PARENTS, SUBSIDIARIES, AFFILIATES, OWNERS, AGENTS AND REPRESENTATIVES FROM AND AGAINST ANY LIABILITY FOR ANY DAMAGES, INJURY OR LOSSES, TO ANY PERSON (INCLUDING DEATH), OR PROPERTY, OF ANY KIND RESULTING IN WHOLE OR IN PART, DIRECTLY OR INDIRECTLY FROM ACCEPTANCE, POSSESSION, MISUSE OR USE OF THE PRIZE OR PARTICIPATION IN ANY SWEEPSTAKES-RELATED ACTIVITY OR PARTICIPATION IN THE SWEEPSTAKES.

10. Limitations of Liability: BEC shall not be held responsible for late, misdirected, incomplete, or undeliverable entries. BEC may prohibit an Entrant from participating in the Sweepstakes or winning a Prize if, in its sole discretion, it determines that said Entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other unfair play, or intending to annoy, abuse, threaten or harass any other Entrants or BEC's representatives or employees. If, for any reason, the Sweepstakes is not capable of running as planned including, but not limited to, by reason of tampering, unauthorized intervention, labor dispute, fraud, or any other causes beyond the control of BEC which, in the sole opinion of BEC, corrupts or affects the administration, security, fairness, integrity or proper conduct of the promotion, then BEC reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes and select the Winners based on entries received prior to the action taken.

11. Claims/Choice of Law: (a) Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes, but in no event attorneys' fees; and (b) under no circumstances will Entrant be permitted to seek the award of, and Entrant hereby waives all rights to claim, punitive, incidental and consequential damages or any other damages, other than actual out-of-pocket expenses, and hereby waives all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Sweepstakes Rules, or the rights and obligations of Entrants and/or BEC in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of New York, without regard for conflicts of law doctrine, and all proceedings shall take place in the State of New York. All Entrants agree to submit to the exclusive jurisdiction of the courts of the State of New York and agree to waive the right to a jury trial with respect to any claim or dispute with regard to any aspect of the Sweepstakes or Official Sweepstakes Rules.
