1. 2. Sweepstakes Period: The “Sweepstakes Period” means the period of time beginning at 12:00 AM on October 28, 2021 and ending at 11:59 PM on [July 31, 2022]; provided, that, each Winner (as defined below) shall be removed from the entry pool after they are selected as a Winner. In order to qualify for any specific Prize, entries must be received during the Sweepstakes Period prior to the selection date listed in Section 1 above (each, a “Selection Date”) for such Prize. Any entries received thereafter shall be null and void, and ineligible for the relevant Prize. The Brooklyn Parties are not responsible for late, incomplete, or misdirected entries, nor is it obligated to publicly announce the Sweepstakes results.

3. To Enter: NO PURCHASE NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. A PURCHASE WILL NOT INCREASE OR IMPACT YOUR CHANCES OF WINNING. In order to be entered into the Sweepstakes, an Entrant must, during the Sweepstakes Period, enter the Sweepstakes in the manner described in Section 1 above.

Limit: One (1) entry per person. If an Entrant completes multiple entry forms during the Sweepstakes Period, only the first entry will be considered. All entries become the property of BKLYN.

By entering the Sweepstakes in the manner described above, an Entrant consents (a) to being contacted by BKLYN, NYL, Microsoft Corporation (“Microsoft”), and each of their affiliates and designees; and (b) to be bound by, and comply with, all of the terms and conditions set forth in these Official Sweepstakes Rules.

4. Eligibility: VOID WHERE PROHIBITED. Entrants must be at least 10 years of age at the time of entry and reside within the State of New York, New Jersey, or Connecticut. **Individuals who are under 18 years of age must be entered by a parent or guardian on his or her behalf.** Sweepstakes is void where prohibited or restricted by law. Employees, officers, and directors (and their parents, siblings, spouses, and children) of (a) BKLYN, NYL, and Microsoft (b) their advertising or promotional agencies, and (c) their respective parents, subsidiaries, or affiliates, are not eligible to participate in the Sweepstakes.

5. Selection of the Winners and Notification: Subject to the terms and conditions set forth herein, there will be one (1) winner for each Prize listed in Section 1 above, for a total of thirteen (13) winners, (each, a “Winner”), randomly selected from among all qualifying Entrants. The Winner for each Prize will be chosen on or about the Selection Date for the applicable Prize. Each Entrant may not win more than one (1) Prize.

Each Winner will be notified via email on or about the date that is one week after he/she is selected as a Winner. If a Winner is under the age of 18, the Prize must be collected by such Winner’s parent or guardian on such Winner’s behalf. If a Winner: (a) is unreachable; (b) does not make direct contact with the applicable Brooklyn Party (or such Brooklyn Party’s designee) by the date specified in the notification message; or (c) fails to accept his/her Prize, the applicable Brooklyn Party reserves the right, in its sole and absolute discretion, to disqualify such Winner and to select a replacement Winner from the remaining qualifying Entrants. The Brooklyn Parties shall not be responsible for failed attempts to notify a Winner and no responsibility is assumed by the Brooklyn Parties for any correspondence returned as undeliverable or any other problems associated with attempt(s) to notify a Winner. Winner Verification: Upon the request of either Brooklyn Party, each Winner (or, if such Winner is under the age of 18, then such Winner's parent or guardian on such Winner's behalf) must sign and return the following documents: (a) an affidavit of eligibility; (b) a liability/publicity release in form and substance satisfactory to such Brooklyn Party; and (c) any other releases and waivers requested by such Brooklyn Party, releasing the Brooklyn Parties (to the fullest extent permitted by law) from any and all liability, loss, claims, demands and causes of action for or related to personal injury, damage, theft, loss, or any other harm suffered in connection with the Sweepstakes or the applicable Prize. If any of the foregoing documents are not completed, signed, and returned prior to the deadline noted therein, or if a Winner is deemed by either Brooklyn Party to be ineligible or not to have complied with these Official Sweepstakes Rules, then such Winner will be disqualified and an alternate Winner will be selected from the remaining eligible entries, time permitting.

7. Prize Conditions, Terms, and Restrictions: Only the Prizes described in these Official Sweepstakes Rules shall be awarded and no substitutions, cash equivalents, and/or redemptions shall be made, except that, in the event of Prize unavailability, the Brooklyn Parties reserve the right to substitute such Prize with another prize of equal or greater value, in the Brooklyn Parties' sole discretion. Unless otherwise set forth herein, each Winner shall be solely responsible for any and all costs not specifically described as part of the applicable Prize including any and all of his/her travel expenses and accommodations.

Except where prohibited by law, Prize acceptance constitutes a release granting the Brooklyn Parties the right to use such Winner's names, likenesses, statements (if true), biographical information, voices, and cities and states of residence for advertising, marketing, and publicity purposes on a worldwide basis (without review by such Winner) and in all forms of media, without compensation, remuneration, or other authorization. The Brooklyn Parties expressly disclaim any responsibility or liability in connection with injury or loss to any person or property relating to redemption of the Prizes. The Brooklyn Parties make no representations or warranties in connection with the Prizes. Restrictions, conditions, and limitations apply.

8. Posting Terms and License to Use Entrant Personal Information: In order to promote, market, and publicize the Sweepstakes, the Brooklyn Parties and their respective affiliates may require a license to use any and all information, materials, and content submitted in the Sweepstakes including, but not limited to, each Entrant's name (and likeness), biographical information, and any other personal information submitted. Accordingly, by submitting an entry, each Entrant expressly grants to the Brooklyn Parties a worldwide, perpetual, irrevocable, royalty-free, non-exclusive, sub-licensable, and transferable right and license to use all of the foregoing, however the Brooklyn Parties may deem fit in their sole and absolute discretion, in connection with the Sweepstakes.

9. Sweepstakes Conditions: The Sweepstakes is governed by and subject to all applicable federal, state, and local laws. By participating, Entrants waive any right to claim ambiguity in the Sweepstakes or in these Official Sweepstakes Rules. Any violation of these Official Sweepstakes Rules by an Entrant may result in disqualification and any violation of these Official Sweepstakes Rules by any Winner will result in such Winner's disqualification as a Winner and all privileges as a Winner shall be immediately terminated. TO THE FULLEST EXTENT PERMITTED BY LAW, EACH ENTRANT RELEASES, DISCHARGES, AND AGREES TO INDEMNIFY AND HOLD HARMLESS BKLYN, NYL, MICROSOFT, THE NATIONAL BASKETBALL ASSOCIATION AND ITS MEMBER CLUBS, NBA PROPERTIES, INC., THE WOMEN'S NATIONAL BASKETBALL ASSOCIATION AND ITS MEMBER CLUBS, BROOKLYN EVENTS CENTER, LLC, AEG MANAGEMENT BROOKLYN, LLC, BROOKLYN ARENA LOCAL DEVELOPMENT CORPORATION, AND EACH OF THEIR RESPECTIVE OWNERS, AFFILIATES, AND SUBSIDIARIES, AND ALL OF THEIR RESPECTIVE DIRECTORS,

OFFICERS, EMPLOYEES, MEMBERS, MANAGERS, AGENTS, SPONSORS, LANDLORDS, TENANTS, LICENSEES, CONTRACTORS, REPRESENTATIVES, SUCCESSORS, AND ASSIGNS FROM AND AGAINST ANY LIABILITY FOR ANY DAMAGES, INJURY, OR LOSSES TO ANY PERSON (INCLUDING DEATH) OR PROPERTY OF ANY KIND RESULTING IN WHOLE OR IN PART, DIRECTLY OR INDIRECTLY, FROM ACCEPTANCE, POSSESSION, MISUSE, OR USE OF A PRIZE, OR PARTICIPATION IN ANY SWEEPSTAKES-RELATED ACTIVITY, OR PARTICIPATION IN THE SWEEPSTAKES.

10. Limitations of Liability: The Brooklyn Parties shall not be held responsible for late, misdirected, incomplete, or undeliverable entries. Either Brooklyn Party may prohibit an Entrant from participating in the Sweepstakes or winning a Prize if, in its sole discretion, it determines that said Entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other unfair play, or intending to annoy, abuse, threaten, or harass any other Entrant or Brooklyn Party representative or employee. If, for any reason, the Sweepstakes is not capable of running as planned including, but not limited to, by reason of tampering, unauthorized intervention, labor dispute, fraud, or any other causes beyond the control of the Brooklyn Parties which, in the sole opinion of the Brooklyn Parties, corrupts or affects the administration, security, fairness, integrity, or proper conduct of the promotion, then the Brooklyn Parties reserve the right, in its sole discretion, to cancel, terminate, modify, or suspend the Sweepstakes and select the Winners based on entries received prior to the action taken.

11. Claims/Choice of Law: (a) Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes, but in no event attorneys' fees; and (b) under no circumstances will any Entrant be permitted to seek the award of, and Entrant hereby waives all rights to claim, punitive, incidental, and consequential damages or any other damages, other than actual out-of-pocket expenses, and hereby waives all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Sweepstakes Rules, or the rights and obligations of Entrants and/or the Brooklyn Parties in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of New York, without regard for conflicts of law doctrine, and all proceedings shall take place in the State of New York.
